Christmas Inspiration

During the Christmas season the greatest stories are those found in the Bible, the books of prayer and the hearts of the people. The temptation is to write about these stories, prayers and people's feelings, but what I want to write about today is a little Christmas history and how that history can be an inspiration to us and to get us moving. It was on Christmas night back in 1776, that George Washington planned to lead his 5,400 troops across the Delaware River hoping to surprise a Hessian force celebrating Christmas at their winter quarters in Trenton, New Jersey. This unconventional attack came after several months of substantial defeats for Washington's army. So, about 11 pm. on Christmas eve, Washington's army commenced its crossing of the half-frozen river at three locations. 2,400 soldiers led by Washington successfully braved the icy and freezing river with the shallow draft boats and reached the New Jersey side of the Delaware just before dawn. The other two divisions, made up of some 3,000 men, heavy artillery pieces and horses were transported on large flat-bottomed ferries but they failed to reach the meeting point.

At approximately 8 am. on the morning of December 26, Washington's only force of 2,400 soldiers without heavy artillery and horses, separated into two columns, reached the outskirts of Trenton and descended on the unsuspecting Hessians. Trenton's 1,400 Hessian defenders were groggy from the previous evening's festivities and underestimated the Patriot threat after months of decisive British victories. Washington's men quickly overwhelmed the Germans' defenses, and by 9:30 am. the town was surrounded. Although several hundred Hessians escaped, nearly 1,000 were captured at the cost of only four American lives. However, because most of Washington's army had failed to cross the Delaware, he was without adequate men, artillery or horses and was forced to withdraw from the town.

The victory was not particularly significant from a strategic point of view, but news of Washington's initiative raised the spirits of the American colonists, bolstered sagging morale in his army and encouraged more men to join the ranks who previously feared that the Continental Army was incapable of victory.

Most of us still have our Delawares to cross. Perhaps if we remember the example of Washington, we will be inspired this month to get moving. To buy our own business and gain greater control of our destiny and provide us with greater long-term security while not only providing an income stream but also providing equity and wealth protection that is not provided with most jobs.

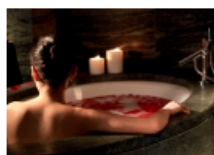
