The Trump effect is really in high gear. Trump says "I promised that my policies would allow companies like Apple to bring massive amounts of money back to the United States. Great to see Apple follow through as a result of TAX CUTS. Huge win for American workers and the USA!" In just 10 days after the tax cuts over 164 big companies gave bonuses to employees, citing the tax cuts as their reason for doing so.

The DOW hit 26,000. Stocks traded higher on Wednesday, January 17 following the release of stronger-than-expected quarterly results from some of the biggest U.S. companies. The rally on Wednesday gave the Dow its best percentage gain since November. And it showed that the upward trend remains intact. It took just seven trading days for the Dow to climb from 25,000 to 26,000. While that is just a 4% advance, it's part of a broader surge that has raised the Dow 42% during the Trump era.
